Committee Member Fahy shared newspaper articles on 301 Ocean, The Castle house. She stated she would like to see The Juno Beach Fish House (former Howard Johnsons) and TerMarsch on the trails map.

Committee Member Ferguson stated The Waterford should be added to the map.

The committee discussed not having a site stop south of Kagan Park.

The committee discussed gathering as much information as possible at this time on each topic and pare it down depending on the media; the map/brochure may need less but the mobile app, website, and audio would need more information.
