Matt's enthusiasm and dedication to the Town was evident in his everyday operations and duties. Over



the past 35 years, Matt has been an essential figure in helping to improve and maintain the Town in so many ways. He assisted in the construction of the Town Center building in 1990-1991, which has become a wonderful center piece of the Town's social and business activities. He even put on his casual wear to help

move the Town's documents and furnishings from the renovated Standard Oil Gas Station, that had served as the first Town Hall for 30 years, to the new Town Center building. He obtained many Certificates of Achievement for Excellence in Financial Reporting on behalf of the Town from the Government Finance Officers Association. The project was awarded to CK Contractors & Development, and they have hit the ground running...or should I say digging? They started the first of August and are on schedule to complete it by the first of the year. If you have

driven down Universe Boulevard and have seen the 48" drainage pipe, you must certainly have a new appreciation for this undertaking. There is a lot of work involved in putting this large of a pipe in a very congested area with lots of other existing utilities. # From the DESK OF THE MAYOR

## ALEXANDER COOKE



*To All my Juno Beach Neighbors,*

As we turn the corner into Fall and return to the "High Season", I would like to thank all of those that continue to support and voice their thoughts on the future of our town.

We have worked hard to protect and maintain the beauty of Juno Beach, there is more to be done. Now that the heat of the warmest summer on record is dissipating, we can see what must be done to keep Juno thriving and continue to be an example for the other towns around us.

A few groups that must be mentioned for their work over the past few months and years.

• **Loggerhead Marinelife Center** (LMC) had its best recorded nesting season with over 25,000 nests, in comparison 2019 the last highest was a little over 19,000 nests. I had the pleasure of discussing this with Andy Derhart (CEO of LMC), and this is the

outcome of over 30+ years of work.

• **The Ecology Group and Parks and Rec Foundation** began their Orchid project. They have mounted Orchids around Pelican Lake on trees to add to the beauty of our community. These orchids over time will blossom and attach themselves to the trees. We should see more Orchids appearing over time, but if you look closely at the south end of the lake you can see the first few.

All of these items have a common element, the unique natural elements that both exist and are capable of existing in Juno Beach. In my previous letter, I discussed some conservation items, I wish to further that theme here. Of note my discussion with Mr. Derhart had a key element, we must do all we can to protect our natural environment just because the nests are at an all-time high does not negate the

risks of the heat we saw this summer and the potential of future summers being hotter. Let's lead by example and limit our use of plastic bags as well as balloons, these are small items, but every bit helps. Additionally, as a town we will work to keep our green spaces both green and producing more shade.

We have had a busy summer; a few major items have occurred, and you all should be made aware of:

1. The Town Charter Review recently came to an end and we, the council, will be voting on changes in upcoming meetings.

2. We are currently in the final steps of finding a new town Auditor, the RFP's have gone out and we are awaiting responses.

3. An ordinance to end gas leaf blowers passed and the education process will begin in October and last one year before the ordinance takes full effect. This will reduce both continuous noise and air pollution in our community.

On a final note, please join all of us on the first Friday of each month for council hour and the first Wednesday of the month for Coffee with a Cop. Both great opportunities to raise questions and speak with us all.

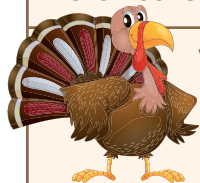

### Important 2023 Hurricane Season Information

In the event that a Tropical Storm/ Hurricane Watch or Warning is issued for our area, precautions should be taken to ensure the safety of our residents, visitors and personal property. Such precautions include but may not be limited to:

#### —Residential Properties—

- Ensure all unsecured items are either secured or relocated to a safe location. Examples include patio fur-

niture, grills, storage containers and other miscellaneous items, etc.

- Remove furniture/items stored on balconies and patios.
- Do not trim trees/palm trees after a hurricane warning has been issued for our area.

#### —Construction Sites—

- Secure/remove all potentially hazardous objects such as temporary toilets, lumber, metal, forms,

other loose building materials, ladders, scaffolding, containers, drums, cylinders, roofing tiles/shingles, and other construction containers, items or debris.

- Remove roll-offs from sites if at all possible. Minimally, roll-offs must be covered and tightly secured.
- Ensure erosion controls are in place and secure.
- Remove all temporary signage.

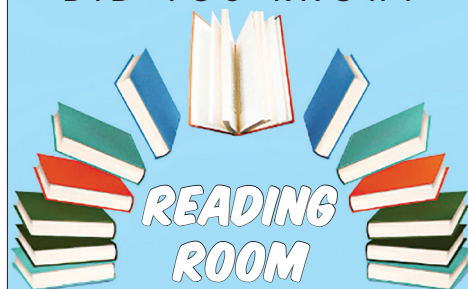

# TOWN OF JUNO BEACH FLOOD HAZARD INFORMATION

(Last Revised August, 2023)

*The Town of Juno Beach has applied through the Federal Emergency Management Association and received a 25% discount for Special Flood Hazard Areas (SFHA) and 10% discount for non-SFHA on **Flood Insurance for Juno Beach property owners**. During extended periods of heavy rainfall, some neighborhoods within the town are subject to flooding. Since you are in a flood hazard area, this information will address issues designed to protect you and reduce loss of value to your property as a result of floods.*

## [Notice to Floodplain Residents]

### ► FLOOD HAZARD

A flood hazard can occur when tropical storms, hurricanes or other heavy rainstorms occur. Although the Town has not experienced any major floods, the areas prone to flooding are: areas along US Hwy 1, Pelican Lake; coastal areas/shoreline; and Inland bodies of water. If your property floods and you file two or more claims worth \$1,000 or more within any 10-yr period you are considered a "repetitive loss" property. Please contact the Town to discuss options to flood proof your property and ways to mitigate flood damage.

### ► PROTECT YOURSELF

Recognize the flood warning signals; when flood warnings are issued, it will be done by sirens and loudspeakers from police vehicles who will give evacuation routes. The main evacuation route will be US Hwy1. Stay tuned to local TV or radio stations for information. Designate a meeting place with family/friends if an evacuation does occur. To prevent drowning, do not drive or otherwise go into any flood waters. Sign up for instant messaging through Palm Beach County's Emergency Notification System [www.alertpbc.com](http://www.alertpbc.com).

### ► PREPAREDNESS

The Town staff is here to assist you with Hurricane, Flood and Disaster Preparation. FEMA brochures are available to learn how to prepare and pro-

tect yourself and your property. Visit the town center for more information.

### ► FLOOD INSURANCE

The Town of Juno Beach is a barrier island and certain areas may be prone to flooding. Flooding is not covered by homeowners' insurance; a separate flood policy is necessary. Flood insurance is available through the National Flood Insurance Program (NFIP). This insurance is backed by the Federal Government and FEMA. **All property owners should contact their insurance agent** to receive a quote and it is recommended that renters also have a policy to cover personal contents. Ask your insurance agent about a low-cost Preferred Risk Policy. Once flood insurance is obtained, there is a **30-day delay** before the policy is in full force and effect.

*You can insure your residential property with flood insurance:*

- **\$250,000 for the building and \$100,000 for your contents.**

*For non-residential buildings you can insure for up to:*

- **\$500,000 for the building and \$500,000 for your contents.**

### ► PROPERTY PROTECTION

*You can minimize damage to a structure with a few simple acts:*

- ◆ Store materials like sandbags, plywood, and plastic sheeting to protect your house from flood waters and to make quick repairs after a severe storm.
- ◆ Secure your home before leaving. Bring outdoor belongings such as garbage cans and patio furniture inside the house or tie them down securely. Move essential items and furniture to the upper floors; lock doors and windows.
- ◆ Protect windows with storm shutters.
- ◆ Elevate the building and all electrical equipment above the flood level.
- ◆ Dry or wet flood-proofing the building to limit water damage and intrusion.
- ◆ Redirect drainage away from buildings.
- ◆ Maintain storm drains and keep swales clear of debris.
- ◆ Correct sewer back-up problems.

### ► BUILD RESPONSIBLY

A permit is mandatory before you build or make structural improvements. Contact the Planning & Zoning Department at **(561) 656-0306** prior to any construction activities or to report illegal floodplain development.

### ► PROTECT THE DRAINAGE SYSTEM

It is illegal for any solid, liquid or gaseous matter to enter the drainage system. Proper drainage will help reduce the risk of flooding. Town staff inspects the drainage system and removes blockages that are found or reported. If you live near Pelican Lake or other areas where waters flow, you can help in this process by keeping areas clear of debris. Reports of any violations should be made to the Code Compliance Dept. at **(561) 627-0818**.

### ► PROTECT NATURAL FLOODPLAIN FUNCTIONS

Juno Hills Scrub site, 148 acres northwest of Donald Ross Road and U.S. Hwy 1 and 42 acres east of U.S. Hwy 1 and 341 acres southeast of Donald Ross and Ellison Wilson Road have been designated as Environmentally Sensitive Lands. These undisturbed natural areas of Juno Beach, act as a natural storage area for flood waters which reduce the possibility of flooding nearby residences and help to recharge our groundwater aquifer. Please help keep this area natural and beautiful by reporting any illegal dumping and littering violations to the Town at **(561) 626-1122**.

### ► MAP DETERMINATIONS, ADDITIONAL INFORMATION

The Town provides map determinations to let you know what flood zone you are in.

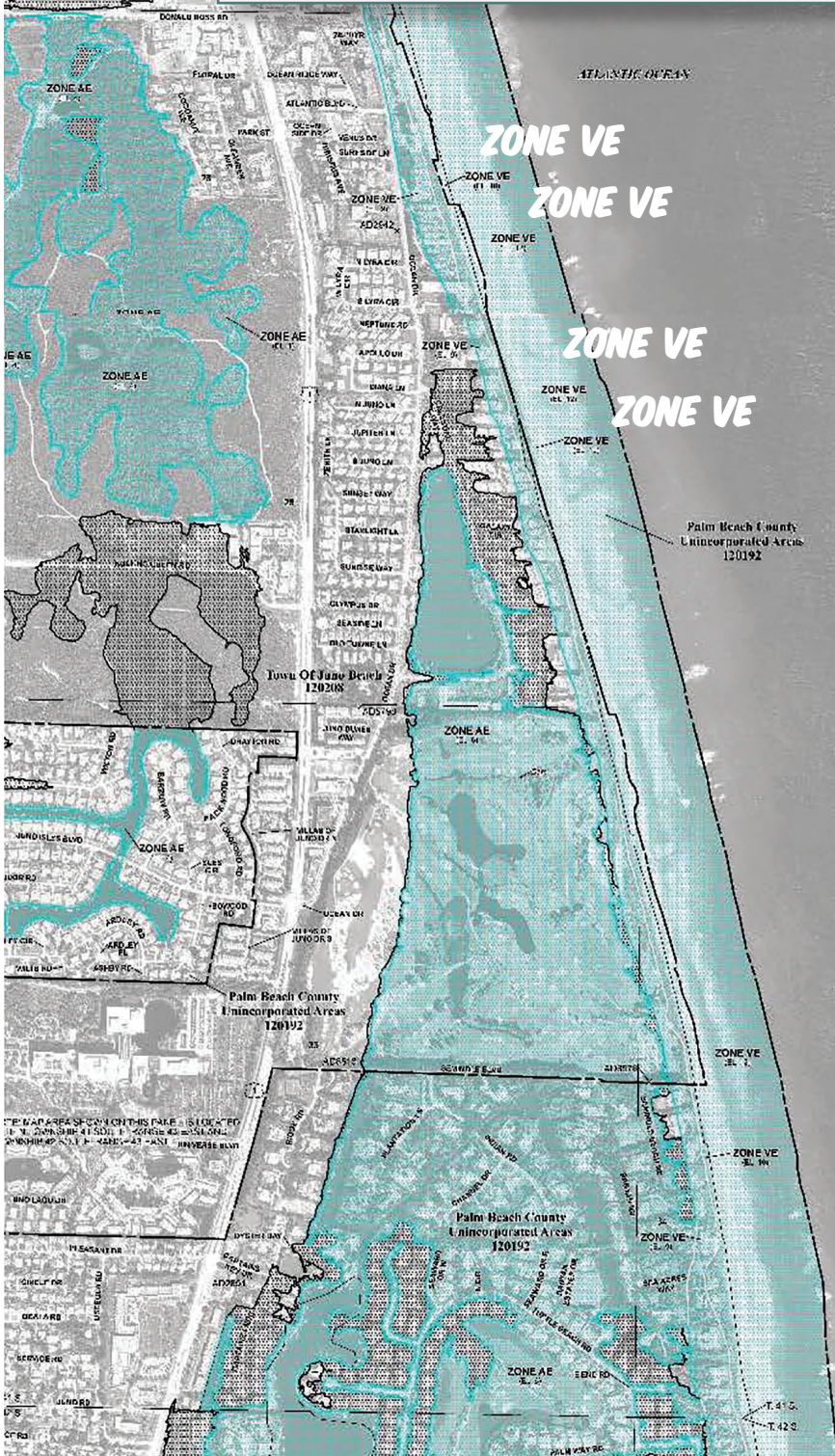

## TOWN UPDATES



### NEW Ordinance Regarding Gas-Powered Leaf Blowers

On August 23<sup>rd</sup>, 2023, the Town of Juno Beach adopted Ordinance No. 768 regarding the use of gasoline-powered leaf blowers within the Town of Juno Beach. Effective October 1, 2024 the use of gasoline powered leaf blowers is prohibited on any property within town limits. The purpose of this ordinance is to minimize, to the extent possible, the effects of pollution (noise and other environmental hazards/fumes) during the operation of such equipment. In an effort to pro-

vide property owners sufficient time to comply, the Town Council graciously authorized an extended compliance date of October 1<sup>st</sup>, 2024. *Following that date, only electric or battery operated leaf blowers may be used.* This ordinance is similar to others adopted by neighboring municipalities. NOTE: Leaf blower is defined as “any air blowing machine that uses a concentrated stream of air to push, propel, or blow dirt, dust, leaves, grass clippings, trimmings, refuse or debris.”

Of the many accomplishments, the most notable is probably his assistance in leading the Town to a debt-free status in April 2013 and still to date the Town remains debt-free. He helped increase the Town's reserves from zero to 100% of the annual operating budget, a feature not common in local, state, or federal government. He spearheaded the Landmarks Advisory Committee from 2018 to 2022 and currently serves as President of the Juno Beach Historical Society.

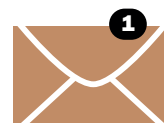
