56th Annual Professional Municipal Clerks Week ► May 4th to May 10th, 2025



Welcome to the Town's Spring Newsletter,

As always, I'm pleased to bring you updates on what's been happening in town since our last edition.

It is an honor to serve as your Mayor. I am grateful for the opportunity to work alongside our residents drawing on my 25 years of experience and history in the beautiful Town of Juno Beach.

NEW TOWN MANAGER

The most important topic in this edition is the Council's unanimous selection of a new Town Manager. On March 7th, 2025, the Council voted to appoint Mr. Robert Cole to the position of Town Manager. We look forward to welcoming Rob to Juno Beach. Rob will start on March 31st, 2025. Please stop in and give him a warm welcome. And a big thank you to Interim Town Manager Frank Davila and Town Clerk Caitlin Copeland as well as all our Department Heads and Staff for the amazing job they have done while Council went through the approval process of hiring our new Town Manager.

During our Public Input Session on Master Planning on March 13th, 2025, several questions were raised that I'd like to address.

Traffic Concerns at US1 & Donald Ross Rd.

Council unanimously opposed adding any turn lanes that would compromise the beauty of the medians and iconic Medjool palms.

Protection of Natural Areas, Environmentally Sensitive Land (ESL), and Preserves

A common question raised was whether the Town's Environmentally Sensitive Land (ESL) and preserves are protected and whether the County could take ESL land if the Town develops residential areas over commercial. It has been stated that even with the full build out of residential units in Juno Beach, the Town would not reach a threshold requiring additional services that would infringe on the ESL land. Areas of the ESL (Preserves) are also protected by a 99-year lease agreement.

Additionally, a third-party conservation easement, held by Conservation Florida since the 1990s, provides an extra layer of protection from a group called *Conservation Florida* that started in the 1990s for our natural areas. Any sale or repurposing of these lands would require a unanimous vote, along with approval from the County Commission and a unanimous vote from the Council.

U.S. Coast Guard Bridge Opening Requests

We continue to pursue restrictions on U.S. Coast Guard bridge openings to help ease congestion. The Coast Guard is currently evaluating data at peak travel times and will determine whether a change is warranted. If they find adjustments are needed, they will initiate the federal rulemaking process.

If the Town receives approval, I hope to advocate for full-time hourly bridge openings to further reduce traffic disruptions. Given Juno Beach's location as a barrier island and its proximity to the Ocean, US-1, and the Intracoastal bridge, an hourly system could ease traffic disruptions and greatly benefit our residents.

Marsinski Bridge Update

I attended a Mayor's meeting with Palm Beach County Mayor Maria Marino and County Administrator Verdina Baker, where they informed us that the Marsinski Bridge has been removed and is no longer included in the County's five-year plan. I will ask Council for a consensus to send a letter to the County to reconsider and/or send a letter specifying the reason it will no longer be included.

Complete Streets

Complete Streets is still actively being pursued which if approved by FDOT and the Town would allow for enhanced safety, slowing of traffic, beautifying of US Highway 1, and make it more pedestrian and bike friendly by separating the roadway bike and pedestrian lanes. This program would be fully funded with up to 5 million dollars from the Florida Department of Transportation.

Pelican Lake Algae Control

Sterile, grass-eating carp have been introduced into Pelican Lake as a biological method to control algae. These fish feed on Chara and Marine Naiad, the aquatic vegetation that contributed to last year's algae overgrowth. This approach is intended to work alongside the scheduled maintenance treatments previously approved by the Town Council, hopefully reducing the need for costly mechanical removal in the future.

Development Updates

The Town has not received any new requests for development on commercial or mixed-use sites.

Moratorium on Mixed-Use Commercial Development

The moratorium on commercial mixeduse development was passed at the March 26th, 2025 meeting. This 9-month to 1-year period provides a critical window to conduct a comprehensive analysis of the potential impacts of both commercial and residential projects on our community, traffic, and infrastructure.



Please Help Protect Our Nesting Sea Turtles and Their Hatchlings by Eliminating and/or Minimizing (to the extent possible) Lighting That May be Visible From the Beach

Beach front property owners are required by state, county, and local regulations to eliminate lighting visible from the beach in order to minimize potential impacts on adult female turtles and their hatchlings. This includes eliminating exterior lighting; i.e. porch/patio lighting, pool lighting, security lighting, landscape lighting, etc., as well as potentially problematic indoor lighting which may include lights that are located directly adjacent to windows and bright overhead fixtures. Please also ensure that all beach chairs, umbrellas, etc., are removed from the beach and dune daily as these can trap sea turtles as the attempt to nest!

FRDAP GRANT RECEIVED TO FUND JUNO BEACH WALKOVER RENNOVATIONS

Sealed Bid Will Be Awarded to One Contractor This Summer

The Town has received a Florida Recreation Development Assistance Program (FRDAP) grant to renovate the most recently added beach access. JB-0 is located at the intersection of Donald Ross Road and Ocean Drive. The Town's engineers are working on a proposed design for the dune structure and to improve the drainage at this site. Due to turtle nesting season there will be construction constraints. Construction is only allowed from Nov-Feb for projects of this nature. A sealed bid will be advertised this summer and awarded to a skilled contractor.

Strategic Plan Development

A draft of the proposed Strategic Plan will be presented at a public hearing at a future date. At that time, the Town could either adopt the plan or defer it to a subsequent meeting for further revisions before adoption.

This Strategic Plan synthesizes input from approximately 40 individuals over 7 months. It is guided by a vision and 10 guiding principles. The draft outlines 39 prioritized action strategies over the next 5 years in pursuit of four key goal areas:

- Administrative Excellence
- Council Effectiveness
- Managing Growth
- ► Healthier Environment

Dune Walkover Renovation (JB0)

The Council will be reviewing the survey, civil engineering plans, and elevation changes for the northernmost dune walkover (JB0). Preserving the current footprint is important, as this dune walkover is defined by the beau-

tiful canopy of sea grapes that create a unique and serene atmosphere. Therefore, maintaining the natural integrity of this entrance while enhancing the walkover for public use is a priority.

Architectural Review Board and Proposed Zoning Code Changes

The Architectural Review Board and proposed zoning code changes will be discussed in a **workshop** tentatively scheduled for **May** 2^{nd} , 2025.

Certain decisions, such as changes to Town codes, have significant implications. Every proposed code change must be carefully evaluated to avoid unintended consequences, including potential infringements on property rights and negative impacts on home values. Thoughtful governance requires considering how any change might affect all residents and their property values.

Several proposed code changes for single-family homes will be discussed in

Pruning Dune Vegetation

Pruning dune vegetation may seem desirable to a property owner in order to provide a clear ocean view. Removing too much vegetation can hurt the fragile dune structure and impact sea turtles.

A well-developed stand of sea grapes is essential to the stability of the beach and dune, and protection of upland buildings from storm-induced erosion and blowing sand and salt spray. Sea grapes also block light from the beach where it could otherwise interfere with sea turtle nesting and disorient emerging hatchlings.

All pruning of native dune vegetation within the Town's 50-foot setback west of the Coastal Construction Control Line (CCCL) shall be **trimmed no lower than five feet above grade**. For trimming below five feet, please contact Code Compliance Officer Mrs. Lynn Hamel to inquire about submitting a Seagrape/Dune Vegetation Trimming Permit. Please note that an FDEP may be required. TOWN OF JUNO BEACH FLOOD HAZARD INFORMATION

(Last Revised March 2025)

The Town of Juno Beach has applied through the Federal Emergency Management Association and received a 20% Flood Insurance discount for Special Flood Hazard Areas (SFHA). During extended periods of heavy rainfall, some neighborhoods within the town are subject to flooding. Since you are in a flood hazard area, this information will address issues designed to protect you and reduce loss of value to your property as a result of floods.


[Notice to Floodplain Residents]

FLOOD HAZARD

A flood hazard can occur when tropical storms, hurricanes or other heavy rainstorms occur. Although the Town has not experienced any major floods, the areas prone to flooding are areas along US Hwy 1, Pelican Lake; coastal areas/shoreline; and Inland bodies of water. If your property floods and you file two or more claims worth \$1,000 or more within any 10-yr period, you are considered a "repetitive loss" property. Please contact the Town to discuss options to flood proof your property and ways to mitigate flood damage.

PROTECT YOURSELF

Recognize the flood warning signals; when flood warnings are issued, it will be done by sirens and loudspeakers from police vehicles who will give evacuation routes. The main evacuation route will be US Hwy 1. Stay tuned to local TV or radio stations for information. Designate a meeting place with family/ friends if an evacuation does occur. To prevent drowning, do not drive or otherwise go into any flood waters. Sign up for instant messaging through Palm Beach County's Emergency Notification System **www.alertpbc.com.**





We encourage all property owners in the "VE" Flood Zone to contact their insurance agent about proper flood coverage. PREPAREDNESS

The Town staff is here to assist you with Hurricane, Flood and Disaster Preparation. FEMA brochures are available to learn how to prepare and protect yourself and your property. *Visit the town center for more information.*

FLOOD INSURANCE

The Town of Juno Beach is a barrier island and certain areas may be prone to flooding. Flooding is not covered by homeowners' insurance; a separate flood policy is necessary. Flood insurance is available through the National Flood Insurance Program (NFIP). This insurance is backed by the Federal Government and FEMA. All property owners should contact their insurance agent to receive a quote and it is recommended that renters also have a policy to cover personal contents. Ask your insurance agent about a low-cost Preferred Risk Policy. Once flood insurance is obtained, there is a 30-day delay before the policy is in full force and effect.

> You Can Insure Your RESIDENTIAL Property With Flood Insurance: \$250,000 for the building and \$100,000 for your contents

> For NON-RESIDENTIAl Buildings You Can Insure For Up To: \$500,000 for the building and \$500,000 for your contents

BUILD RESPONSIBLY

A permit is mandatory before you build or make structural improvements. Contact the **Planning & Zoning Department** at **(561) 656-0306** prior to any construction activities or to report illegal floodplain development.

PROTECT DRAINAGE SYSTEM

It is illegal for any solid, liquid or gaseous matter to enter the drainage system. Proper drainage will help reduce the risk of flooding. Town staff inspects the drainage system and removes blockages that are found or reported. If you live near Pelican Lake or other areas where waters flow, you can help in this process by keeping areas clear of debris. Reports of any violations should be made to the **Code Compliance Dept.** at **(561) 627-0818**.

PROTECT NATURAL FLOOD PLAN FUNCTIONS

Juno Hills Scrub site, 148 acres northwest of Donald Ross Road and U.S. Hwy 1 and 42 acres east of U.S. Hwy 1 and 341 acres southeast of Donald Ross and Ellison Wilson Road have been designated as Environmentally Sensitive Lands. These undisturbed natural areas of Juno Beach, act as a natural storage area for flood waters which reduce the possibility of flooding nearby residences and help to recharge our groundwater aquifer. Please help keep this area nat-

ENSURE PROTECTION TO YOUR PROPERTY

You can minimize damage to a structure with a few simple acts:

- Store materials like sandbags, plywood, and plastic sheeting to protect your house from flood waters and to make quick repairs after a severe storm.
- Secure your home before leaving. Bring outdoor belongings such as garbage cans and patio furniture inside the house or tie them down securely. Move essential items and furniture to the upper floors, lock doors, and windows.
- Protect windows with storm shutters.
- Elevate the building and all electrical equipment above the flood level.
- Dry or wet flood-proofing the building to limit water damage and intrusion.
- Redirect drainage away from the building.
- · Maintain storm drains and keep swales clear of debris.
- · Correct sewer back-up problems.



Municipal Clerks Week the first full week of May and recognizing the essential role Municipal Clerks play in local government.



Some could adversely affect our municipality if passed so Council advised the Town Manager and Town Attorney to work together on opposing those that may impact our community.

Chief of Police Brian Smith requested LifeVacs from our Police Foundation which was approved by the Town Council-a life-saving choking rescue device that will be placed in each Police Vehicle. A LifeVac is a human-powered, non-invasive, single-use airway clearance device designed to remove obstructions from a choking victim's airway, especially when traditional choking protocols have been unsuccessful. Title: Temporary Moratorium on Commercial, Mixed-Use and Multi-Family Development Applications ORDINANCE NO. 792 Effective: March 26, 2025

SUMMARY: Established a temporary moratorium on the acceptance, processing, and consideration of any new application for development approval of a commercial, mixed-use, or multi-family residential project within the corporate limits of the town for a period of up to one year.
